

Whilst "liability cover" insurance can be purchased from a third party* to protect you from the cost of any liability in case of damage, it does not directly release you from the liability associated with hiring a **maui**, Britz or Mighty vehicle.

It is a mandatory requirement for you to accept liability directly with **maui**, Britz or Mighty by way of a liability deposit to cover the standard liability applicable to the vehicle hired.

All vehicles are insured for damage to the vehicle or to the property of a third party. **The daily vehicle rate includes standard liability whereby the hirer leaves a liability deposit.**

This amount (refer below) is **debited** to the hirer's credit or debit card at vehicle collection and is refunded (including the administration fee for Visa and MasterCard credit or debit card) at drop-off provided the vehicle is returned undamaged. In the case of vehicle or property damage, part or all of the liability deposit will be retained, however you can seek reimbursement from the third party* from whom you purchased the liability cover insurance.

This liability can be reduced to NIL** for 2WDs by purchasing the **Liability Reduction Option** or the **Inclusive Pack**. The liability for 4WDs can be reduced to \$500 by purchasing the **Liability Reduction Option** or to NIL by purchasing the **4WD Max Cover** (with the Liability Reduction Option or Inclusive Pack) in addition to the vehicle daily rental rate.

- \$53 per day** for the **maui**: Ultima, Ultima Plus, Cascade, Beach and River and the **Britz**: Venturer, Venturer Plus, Discovery, Explorer and Frontier

4 Britz 4WD Max Cover

recommended option for 4WDs

Extra peace of mind for 4WD adventurers: **NIL liability for 4WDs**

\$275 per rental for Britz 4WD campers (available in addition to the Liability Reduction Option or the Britz Inclusive Pack)

- Liability reduced to NIL** for accidental damage, including damage to tyres and windscreens
- Unlimited accidental damage to overhead and underbody sections of the vehicle
- Unlimited kilometres per day
- Towing and vehicle recovery costs from 4WD roads requiring permission from Britz to travel on

N.B. Credit/debit card authority taken (no deposit required)

*Third party refers to any insurance agent providing travel insurance cover which can include liability cover for rental vehicles.

**Exclusions apply. Refer to the Rental Agreement for further details.

Please note: Per day rate for the Liability Reduction Option and Inclusive Pack will be capped at 50 days. A non-refundable administration fee applies to all Visa, MasterCard and American Express transactions. Credit card administration fees also apply to the Liability Deposit (refundable provided vehicle is undamaged and Visa or Mastercard is used). Only the customer's credit/debit card is acceptable to use for the purpose of the Liability Deposit and the Credit Card Authority. Pre-paid travel cards are not acceptable as a means to provide a Liability Deposit. The credit/debit card holder must be present and able to sign for the Liability Deposit upon vehicle collection. The credit/debit card holder is jointly and severally liable for any damage to the rental vehicle.

Personal injury is covered in most cases through Registration Third Party insurance. **maui**/Britz/Mighty does not accept any liability for personal injuries sustained during the rental, except where such loss or damage is caused by **maui**/Britz/Mighty's (or that of its employees) own negligence or breach of the applicable **maui**/Britz/Mighty Rental Agreement Terms and Conditions, **maui**/Britz/Mighty does not

accept liability for any loss or damage to any personal belongings or property of the Customer (or any person or entity related to the customer). **maui**/Britz/Mighty strongly recommends that the customer takes out personal travel insurance to cover any injury or loss.

Where NIL liability is present you are covered for single vehicle damage (except single vehicle rollover unless you purchase the Inclusive Pack), third party accident and cost for repair/ replacement of unlimited windscreen and tyres. In Australia it is not compulsory for drivers to have private insurance on their own vehicles. Any breach of the exclusions will render all cover void.
